- i.) The engagement will not constitute a regular job or appointment in the ICAR.
- ii.) During the term of engagement, the YP-II shall comply with the Standards of Conduct. Failure to comply with the same will become grounds for termination of the YP-II without notice.

Terms & Conditions

- The above **position is purely temporary and will be filled on a contractual basis.** The post is coterminous and will be offered initially upto 1 year.
- The candidates should be minimum of 21 years and a maximum of 45 years. The age relaxation for SC/ST/OBC is applicable as per the Govt. of India/ ICAR Rules.
