Duration of engagement of the YP-I

Initial engagement of YP-I will be for one year, which may be extended subject to performance and requirement of the services of the YP-I in the Institute.

Eligible candidates must bring the duly filled application in the enclosed proforma (Annexure I& II) along with self-attested photocopies of the documents and original documents at the time of the Interview.


