## Nature of Work:

Primary place of work will be at ICAR-IIAB, Ranchi. Research works involve synthesis and characterization of biocompatible nanoparticles, testing of nanoparticles for ARTs, use of equipment like CASA, phase-contrast/fluorescent microscopes, PCR/qPCR, 2-DE, Western blot, etc., documentation and maintenance of laboratory data, assistance to PI in project.

#### Duration of engagement of the JRF

Initial engagement of JRF will be for one year or till completion of the project whichever is earlier. It may be extended subject to the performance and requirement of the services of the JRF in the Project.

### Tax deduction at source
